The purpose of the Environmental Newsletter is to provide you with an overview of proposed activities and projects in Los Padres National Forest. It is our hope that this information will help you become involved early in the planning process for those proposals which might interest or affect you.

### Analyses Being Scoped

This section includes projects currently under analysis.

## FORESTWIDE

### Analyses in Progress

Oil and Gas Leasing Analysis. Forestwide environmental analysis (EIS) to identify lands which should or should not be made available for oil and gas leasing. The decisions made as a result of this forestwide analysis will not result in on-the-ground activities. Any exploration, drilling or field development which might be proposed following the forestwide study would require further environmental

Pfeiffer Beach. Proposal to rehabilitate the existing day use facility. Includes Sycamore Canyon Road Transportation Study. T.19S., R.1E., Section 35, MDB&M. Monterey District - May, 1994.

Indians West. Analysis of unauthorized road use in the area west of Wagon Caves to the Indians Ranch to mitigate ongoing damage to soils, water quality and heritage resources. Monterey District - May, 1994.

### Analyses in Progress

Big and Little Falls Allotment Permit Re-issuance. Proposal to analyze grazing permit re-issuance for the Big and Little Falls Allotment. Proposal includes 15 cow/calf pairs for about 8.5 months. T.30S., R.14E., Sections 28-33, MDB&M. Santa Lucia District - May, 1995.

## SANTA BARBARA COUNTY

### Analyses Being Scoped

Winchester Gun Club. Proposal to renew an existing use with a 10 year special use permit for a target range. T.5N., R.28W., Section 19 and T.5N., R.29W., Section 24, SBBM. Santa Barbara District - September, 1995.

### Analyses Completed

Los Prietos Boys Camp/Boot Camp. An Environmental Assessment has been completed for the proposal to add a Boot Camp program at the Los Prietos Boys Camp. The proposal included adding new facilities within the permit area along with a maximum of 40 boys between the ages of 13-17. The Boot Camp would be for non-violent delinquent youths from Santa Barbara, Ventura and San Luis Obispo Counties. The public comment period on the EA closed on

Round Potrero Prescribed Burn. A Decision Memo was signed on November 1, 1996, approving a 1500-acre prescribed burn of decadent chaparral within Round Potrero, adjacent to the Sulphur Spring drainage. T.8N., R.26W., Sections 3-5, 8-11, 14, 15, 32 and 33, SBBM. Mount Pinos District - November, 1996.

Camp Cielo. Proposal to issue a new twenty year special use permit to an existing organization camp due to a change in ownership. T.6N., R.29W., Section 32, SBBM. Santa Barbara District - July, 1993.

Sierra Madre Spring Restoration. Proposal to protect six springs (Oak, Montgomery 1&2, Cherry Orchard, Pine Corral and Black Willow) in the Sierra Madre Ridge area from cattle and human impacts. T.8N., R.26W., Section 22, and T.9N., R.27W., Sections 22, 27 and 36, SBBM. Mount Pinos District - January, 1996.

Happy Canyon Allotment Management Plan. Analysis of the Happy Canyon Range Allotment Management Plan to ensure that it is in compliance with the Forest Plan and that all permit revisions are in compliance with NEPA. T.7N., R.29W., SBBM. Santa Barbara District - July, 1994.

Broadcast Peak Communications Site Plan. This site management plan would delineate site boundaries, determine the kinds of uses which are (or would be) appropriate to the site, and identify any areas that could be developed. The plan would also address the technical specifications and management requirements for existing and new facilities that might be constructed. T.5N., R.29W., Section 7, SBBM. Santa Barbara District - September, 1995.

Cuddy Allotment Permit Re-issuance. Proposal to analyze grazing permit re-issuance for the Cuddy Allotment. Proposal includes 19 cow/calf pairs. Mt. Pinos District - May, 1995.

Mt. Pinos Winter Parking Improvement. Proposal to redesign and expand recreational parking facilities within the Mt. Pinos Winter Sports Area. The project would involve the construction of new parking lots, redesign of existing parking lots, and an increase in roadside parking and sanitation and solid waste disposal sites. The revised Environmental Assessment was issued on September 3, 1996. The public

comment period closed on October 4. The Decision Notice will be released after public comments are reviewed. T.9N., R.21W., Sections 33-36 and 26; T.8N., R.21W., Sections 3-5, 8 and 9; T.9N., R.20W., Section 32, SBBM. Mount Pinos District - November, 1993.

## VENTURA COUNTY

Analyses Being Scoped

Grade Valley Guzzlers. Proposal to install four concrete guzzlers in the Grade Valley and Tecuya Ridge area to provide additional water sources for wildlife. T.7N., R.21W., Section 24; T.9N., R.20W., Section 19; T.9N., R.21W., Section 24; T.8N., R.20W., Section 31. Mount Pinos District - November, 1996.

Sespe Trail Reroute. Proposal to relocate approximately 1 mile of the trail in the Bear Creek area to reduce the number of stream crossings, aid public safety, and avoid a large natural landslide covering the trail in this area. T.6N., R.21W., Section 34 and T.5N., R.21W., Sections 4 and 5, SBBM. Ojai District - March, 1996.

North Fork Matilija Trail Reconstruction. Proposal to reconstruct this trail in Matilija Wilderness to allow for public access and use. T.5N., R.24W., Sections 1, 2, 12-15, 22 and T.6N., R.24W., Section 21, SBBM. Ojai District - March, 1996.

Snowy Trail Re-route FEIS. The Record of Decision was signed on October 25, 1996 and the FEIS will be published in the November 15 Federal Register. The appeal period for this document ends December 30, 1996. Mount Pinos District.

Long Dave OHV Trails. A Decision Notice was signed on October 25, 1996, approving the adoption of Alternative D. The appeal period for this EA ends on December 13, 1996. Mount Pinos District.

Analyses in Progress

Coyote Water Development. Proposal to develop one water development on the west end of the Coyote Range Allotment for livestock and wildlife use. T.4N., R.24W., Section 17, SBBM. Ojai District - May, 1996.

Highway 33 Disposal Sites. Proposal by Caltrans to establish longterm seasonal disposal sites at different locations along Highway 33. The disposal sites must accommodate approximately 600,000 yards of slide and slough material over a ten year period. Caltrans is preparing the environmental document. Ojai and Mount Pinos Districts - January, 1996.

Deer Park Allotment Permit Re-issuance. Proposal to analyze permit re-issuance for the Deer Park Allotment. Proposal includes 22 cow/calf pairs. Mount Pinos District - July, 1995.

Sisar Allotment Permit Re-issuance. Proposal to analyze permit re-issuance for the Sisar Allotment. Proposal includes 6 cow/calf pairs. Ojai District - May, 1995.

Rice/Wills Allotment Permit Re-issuance. Proposal to analyze permit re-issuance for the Rice/Wills Allotment. Proposal includes 16 cow/calf pairs. Ojai District - May, 1995.

Quatal Allotment Permit Re-issuance. Proposal to analyze permit re-issuance for the Quatal Allotment. Proposal includes 4 yearlings. Mt. Pinos District - May, 1995.

Ojai Valley Gun Club. Proposal to renew the existing special use permit for the club's facilities in Rose Valley. T.5N., R.22W., Section 4, SBBM. Ojai District - January, 1992.

Piru Creek Mining Activities. An EIS to determine whether to approve Plans of Operation for mining activities along Piru Creek from Pyramid Lake to Lockwood Flats including but not limited to dredging, panning, sluicing, and high banking. Resources potentially affected include archeological sites, water quality and four sensitive wildlife species which depend on riparian areas. Piru Creek is presently being studied for Wild and Scenic River nomination. Mount Pinos District - November, 1993.

Badlands OHV Trail. Analysis of potential routes to connect off-highway vehicle use areas from Grade Valley Road to Ballinger Canyon. Analysis will also evaluate selected routes to serve as a replacement for the Toad Springs OHV trail. T.7N., R.21W., Sections 4-6; T.7N., R.22W., Sections 6, 7; T.7N., R.23W., Sections 1, 11, 12; T.8N., R.21W., Sections 30-32; T.8N., R.22W., Sections 19, 25-36; T.8N., R.23W., Sections 5-7, 15-18, 22-26, 35-36; T.9N., R.23W., Sections 28-29, 32-33; T.9N., R.23W., Sections 7, 14-29; T.9N., R.24W., Sections 6-13, 21-27, 35-36, SBBM. Mount Pinos District - November, 1993.

Lion Campground Connector Trail. Proposal to construct a small parking lot and a .3 mile long trail from Rose Valley Road to the westernmost two loops of Lion Campground for protection of wildlife habitat. T.6N., R.22W., Section 36, SBBM. Ojai District - March, 1994.

Interpretive Displays. Proposal to construct nine interpretive and informational displays at existing trailheads and administrative sites. Ojai District - March, 1994.

Bald Hills and Last Chance Trails. Proposal to reconstruct the Bald Hills Trail in the Matilija Wilderness and the Last Chance Trail in the Sespe Wilderness. Would involve re-establishing trail tread, minor reroutes for resource protection, localized minor blasting, installing waterbars and brushing. T.5N., and T.6N., R.24W., and T.5N. and T.6N., R.21W., SBBM. Ojai District - May, 1993.

Sespe Wilderness Trailheads. Proposal to improve or construct trailheads for the Sespe Wilderness at Lion Campground, Dough Flat, Reyes Peak, Sewart Mountain, Mutau Flat and Cedar Creek/Fishbowls. Ojai and Mount Pinos Districts - September, 1992.
